**MISSION STATEMENT** Greater Wildwood Chamber of Commerce Foundation, INC is a Community Trust. We invest in the people who we believe will contribute to the long-term benefit of our residents, our businesses, and our visitors. To meet that objective, we provide financial assistance for students who reside in the Wildwoods, and to organizations that support charitable activities within the community.

**FINANCIAL ASSISTANCE** is based on financial need, academic performance, leadership potential, and community involvement including but not limited to volunteer hours. Scholarships are awarded annually provided funds are available.

#### SCHOLARSHIP AWARDS

Greater Wildwood Chamber of Commerce Foundation awards scholarships on the basis of a comprehensive process. Areas that are reviewed by the committee include, but are not limited to the following: Academic Accomplishments, Community Service, References, Personal Essay, Career Choice and Financial Need. Greater Wildwood Chamber of Commerce Foundation pays scholarship funds directly to the recipient. Scholarships are awarded at the completion of the first semester if the student has a 2.75 GPA and is enrolled full time for the following semester. The Greater Wildwood Chamber of Commerce Foundation scholarships are awarded without regard to race, color, ethnicity, gender or sexual orientation. Scholarships awarded are based upon the availability of funds and additional qualifying criteria.

#### CRITERIA

- Applicants must have permanent residence status in the Wildwoods (North Wildwood, Wildwood Crest, West Wildwood or Wildwood).
- Applicants must be graduating from Wildwood, Wildwood Catholic Academy, Cape May Vo-Tech or Cape Christian Academy High School.
- Applicants must be completing high school successfully with a minimum unweighted GPA of 2.75 on a 4.0 scale.
- Applicants must be accepted as a full-time student at a college, university, or trade school program for the upcoming academic semester.
- Applicants must demonstrate a need for financial assistance.
- Applicants must be a citizen or legal permanent resident of the United States.
- Applicants must complete and submit a Scholarship Application by Friday, April 11, 2025 @ 4:00pm.
- Scholarship recipients will receive their check for the next semester **only** after their grades from the previous semester have been received.

#### TIMELINE

- Applications must be received by Friday, April 11, 2025 @ 4:00pm. NO EXCEPTIONS
- Applicants are notified if awarded a scholarship by May 2023.

# SCHOLARSHIP APPLICANTS MUST PROVIDE:

- Completed application form.
- Official high school transcript in a sealed envelope from the institution.
- Two academic references from a guidance counselor or teacher.
- A letter completed reference from an employer or other community member.
- Proof of acceptance at an academic, vocational, or technical school for post-secondary studies.
- Proof of residency in the Wildwoods.
- Demonstrated financial need.

## CRITERIA FOR SCHOLARSHIP RECIPIENTS

 Scholarship recipients will receive their check for the next semester only after their grades from the previous semester and full-time enrollment paperwork have been received. Students must receive a 2.75 grade point average based on a 4.0 scale.

**Deadline** for the application is Friday, **April 11**, **2025** @ **4:00pm**. Applications received after this date will not be considered.
